NOTICE INVITING TENDER (NIT)/REQUEST FOR PROPOSAL(RFP)

The Embassy of India in Bamako, Republic of Mali, invites the interested companies dealing in supply and installation of generators, to confirm interest and submit competitive bids for the supply and installation of 1 (one) 30 KVA Diesel Generator Set as per following 'scope of work' at Embassy of India located at 101, Avenue de l'OUA, B.P. 8008 Badalabougou Est, Bamako(Mali)

2. SCOPE OF WORK

Supply and installation of a 30 KVA Diesel generator set at Embassy of India Bamako located at 101, Avenue de l'OUA, Badalabougou Est, B.P. No. 8008, Bamako (Mali), with the following indicative specifications:

The generator will operate as an emergency back-up in case of electricity outage and will supply the Embassy with emergency power for all electrical and electronic devices including, but not limited to, Air Conditions, garden lighting and fence lighting. The generator will have to be installed with a switch key which should automatically operate the generator upon power outage and turn it off once the power supply is back to normal.

3. ELIGIBILITY CRITERIA:

(1) Bidder should demonstrate and explain their technical, professional and practical experience of having supplied and installed similar devices and will need to supply examples of similar supply in last 2 years, including such supply made to any diplomatic Mission or office of any International organization in Mali.

(2) Bidder should submit, in brief, the history of their company with annual turnover. They may also furnish certificate/license, if any, that may indicate their competence for supply and installation of generator sets.

4. SUBMISSION OF BIDS AND OTHER TERMS AND CONDITIONS:

(2) **Manner of Depositing the Bids:** Interested professional companies dealing in supply and installation of generator sets at Bamako may submit their bids in a **sealed cover**. The Envelop should be super-scribed – “**Quotation for supply and installation of Generator to Embassy of India, Bamako**”. Sealed bids should be either hand delivered to the Embassy or sent by registered mail at the address given above so as to reach by the due date and time. Late bids will not be considered. No responsibility will be taken for postal delay or non-delivery/non-receipt of bid documents. Bids sent by FAX or email shall not be considered.

(3) **Last Date and Time for Depositing the Bids:** The bids should be deposited/reach by 1200 hrs, Friday, 3rd November 2017.

(4) **Time and Date of Opening of Bids:** The bids will be opened at 1600 hrs on Friday, 3rd November 2017. In case it is declared a holiday, the bids will be opened on the next working day at the same time.

(5) **Place of Opening of the Bids:** Visitor's Room, Embassy of India, Bamako. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of Bids on the due date and time. The Bids will be read out in the presence of the representatives of all the Bidders. However, the opening of bids will not be postponed due to non-presence of the representatives of the Bidders.

- (6) **Forwarding of Bids**: Bids should be forwarded by bidders under their original letter-head inter alia furnishing details like complete postal & email address of their office.
- (7) **Rejection of Bids** – Canvassing by the bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection.
- (8) **Validity of Bids** – The Bids should remain valid till 3 (three) months from the last of the submission of the Bids.
- (9) **Payment Terms** – No advance payment will be made. Payment for the items supplied under the present Agreement shall be effected by the Buyer in **CFA Franc**. Payment shall be made by direct transfer or by cheque by the Embassy of India, Bamako.
- (10) **Warranty** – The supplier will provide the warranty of at least **12 months** for the items supplied under this contract.
- (11) This RFP is being issued with no financial commitment and the Embassy of India in Bamako reserves the right to change or vary any part thereof any state. Buyer also reserves the right to withdraw the RFP, should it become necessary at any stage. To assist evaluation and comparison of the bids, the Embassy at its discretion, may ask the bidders for clarification on their bids. The clarifications and responses from the bidder shall be in writing.
