II. SCOPE OF WORK: Supply and installation of 40 to 50 KVA Diesel Generator set as per above essential specifications at the Residence of Ambassador of India to Mali at Badalabougou Rue 14 Porte 205, Bamako (Mali). The ideal requirement of the capacity of the DG Set is to be independently assessed by the bidder, taking into consideration the uptimum load of the present electric installations, before submission of their bids.

IV. Manner of Depositing the Bids: Interested professional companies dealing in supply and installation of a Generator set at Bamako may submit their technical and financial bids simulteneously in two separate sealed envelopes. **Technical bid** should consist of all technical details alongwith commercial terms and conditions; and Financial bid should indicate itemwise price for the items mentioned in the technical bid. The Envelope containing Technical Bid should be superscribed - "Technical Bid for supply and installation of a 40-60 KVA Diesel Generator set at the residence of Ambassador of India, Bamako". The Envelop containing Technical Bid should be superscribed - "Financial Bid for supply and installation of a 40-60 KVA Diesel Generator set at the residence of Ambassador of India, Bamako". Both these sealed envelopes are to be put in a bigger envelope, which should also be sealed and duly **super-scribed.** Sealed bids should be hand delivered to the Embassy at the address given above by the due date and time. Late bids will not be considered. No responsibility will be taken for any delay due to any unforeseen circumstances. Bids sent by FAX or email shall not be considered.

- **V.** Last Date and Time for Depositing the Bids: The bids should be deposited/reach the Embassy by 1500 hrs on 17 June 2022.
- VI. <u>Time and Date of Opening of Bids</u>: The Technical Bids will be opened at 1600 hrs on 17th June 2022 and the Financial Bids (of only those bidders, who qualify in their techninal bids), will be opened at 1700 hrs on 17th June 2022. In case it is declared a holiday, the bids will be opened on the next working day at the time indicated herein.
- **VII.** <u>Place of Opening of the Bids</u>: Embassy of India, Bamako. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of Bids on the due date and time. The Bids will be read out in the presence of the representatives of all the Bidders. However, the opening of bids will not be postponed due to non-presence of the representatives of the Bidders.
- **VIII.** <u>Forwarding of Bids</u>: Bids should be forwarded by bidders under their original letter-head inter alia furnishing details like complete postal, email landlind, fax and mobile phone numbers of their office.
- **IX.** <u>Rejection of Bids</u> Canvassing by the bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection.
- **X.** <u>Validity of Bids</u> The Bids should remain valid till 12 (twelve) months from the last date of the submission of the Bids.
- **XI.** <u>Payment Terms</u> No advance payment will be made. Payment for the items supplied under the present Agreement shall be effected by the Buyer in **CFA Franc**. Payment shall be made by direct bank transfer or by cheque by the Embassy of India, Bamako.
- **XII.** <u>Warranty</u> The supplier will provide the warranty of at least **12 months** for the items supplied under this contract.
- **XIII.** This RFP is being issued with no financial commitment and the Embassy reserves the right to change or vary any part thereof at any state. Buyer also reserves the right to withdraw the RFP, should it become necessary at any stage. To assist evaluation and comparison of the bids, the Embassy at its discretion, may ask the bidders for clarification on their bids. The clarifications and responses from the bidder shall be in writing.
